6.2 Municipal Capital Works Projects opens on October 30<sup>th</sup>, 2024 and is open until November 29<sup>th</sup>, 2024. Council Priority 1 is a New Water Supply and Priority 2 is a New Sewer System. Council agreed to move forward with Priority 1 a New Water Supply for this application. Council agreed to go with Englobe Corp. as they were the previous consultant when the application was submitted in 2023.

7.1 Boil Water Advisory – Office staff have been working to get this lifted. It was communicated that Rocky Harbour was missed due to staffing leave and they are working on getting both samples tested. Mayor stated they would call the premiers office about the issue.

7.2 Gros Morne Academy Graduation Venue/Meal – Council agree to donate the hall to the graduation class as they have done this in previous years and will do so for free. Office staff to confirm the date that is needed and ensure it is booked.

7.3 GMTripp Community Business Owner Concern – Local business owner has expressed concern that The Town of Rocky Harbour is missing out on a huge opportunity. Council discusses understanding of the importance of collaboration in driving economic growth. Council discussed making decisions of the best interest of the community and aligning them with the towns own long-term goals. Council discussed how various conversations were had about the project and after much discussion decided to not partake in it due to other financial priorities. Council expressed they are open to setting up a meeting to discuss this further with the Business Association.
