6.1 2024/25 Fire Protection Financial Assistance Grant, Project No.FES-SA240033

The Town initially understood that they were only responsible for their portion of the provincial grant, with the government covering the remainder of the cost for the equipment. However, Town Office staff were later informed that the Town must pay the full amount upfront. Once proof of payment is provided, the provincial government will reimburse 80% of the total cost. The Town has already made a payment of \$24,742.55.



Motion #007-2025 Moved by Deputy Mayor Shears and seconded by Councillor Cullihall.

BE IT RESOLVED that the Town Council of Rocky Harbour agrees to to pay the remaining balance of \$106,503.83 upfront for the purchase of 8 SCBA units, 8 masks, and 16 cylinders from Safety Source. Once payment is confirmed by the provincial government, they will reimburse their portion of the grant, amounting to \$98,970.19. Upon receiving this reimbursement, the Town will transfer the \$106,503.83 back into the Fire Truck account.
