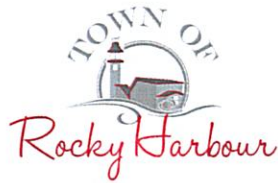
6.12 Arena referees were discussed. Minor hockey asked if town would consider paying 50% of the fees to get them recertified.
