At this time, it is an estimated cost of \$7,000,000.00 and the town's portion would be \$700,000.00. A vote was taken and all 25 residents in attendance are asking for a new water source.



A few questions were asked to the previous Mayor who was in attendance and a former Councilor. This council asked if test flow rates were completed on the wells, and the previous Mayor and councilor said Yes that the flow rates were completed and should be on file at the office.
