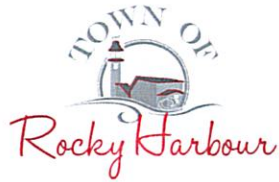

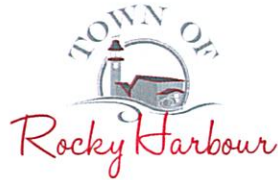

Repairs to boat launch at Rocky Harbour Pond. Town maintenance Foreperson to check on material

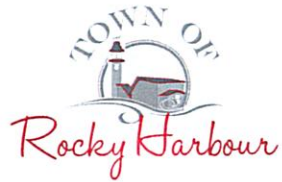
