6.5 Rezoning on Lookout Road:

As revisions to Municipal Plans are not permitted but rather must involve a complete rework at full cost and time, council has agreed to begin the process of granting Discretionary Use to resident.

6.6 Meeting with resident at 85 Main Street North:

Discussed water issues/sewer backups during heavy rain/snow melt events. Crews to investigate further to find possible cause/solution. Will contact resident to present options.

6.8 Crosswalks and Intersections – DOT:

Contacted DOT to find out when these would be completed as line have been done for some weeks; Informed that these are two different crews and next crew should be along by end of month.

6.9 Fingerboards:

Received responses from 32 businesses. Looking into options for other materials as ordering individual Street Signs may be cost prohibitive.

6.10 Pond Boat Launch:

To contact Floyds regarding best material/options as they deal with water impacted environments regularly.

Several residents have complained about another resident flying a flag on his front lawn containing profanity. Will draft letter to resident to ask that it be removed.
